#### FINALIZED 2013 ANNUAL GDP AND 2014 REVISED GDP ESTIMATES

## INTRODUCTION

Gross Domestic Product is the estimate of the total value of final goods and services produced in the country over a a period.

The estimation of the Gross Domestic Product (GDP) is done in stages, with estimates generated at each stage being dependent on available data. Estimates from each stage are progressively designated as provisional, revised and final.

This release contains the revised estimates for 2014 and final estimates for 2013. The estimates for 2014 used data covering four quarters of the year from production units adjusted to cover the whole year, and also targeted annual production of some economic entities. Further revisions to these estimates will be carried out in June 2015.

#### **KEY FINDINGS**

Revised GDP estimates for 2014 showed a growth of 4.0 percent over the 2013 final estimates. The Services sector recorded the highest growth of 5.7 percent, followed by Agriculture (4.6%) and the Industry sector with a growth of 0.9 percent.

Services remain the largest sector. Its share of GDP declined slightly from 49.8 percent in 2013 to 49.6 percent in 2014. The sector's growth rate also decreased from 10.0 percent in 2013 to 5.7 percent in 2014. Two of the subsectors in this sector recorded growth rates above 20 percent. These are the Financial and and Insurance subsector and the Information and Communication subsector.

In the Industry sector, the least growing sector with a share of 28.4 percent, growth declined from 6.6 percent in 2013 to 0.9 percent in 2014. Of all the industrial activities the Mining and Quarrying subsector recorded the highest growth of 3.2 percent in 2014.

The Non-Oil annual GDP growth rate declined from 6.6 percent in 2013 to 4.0 percent in 2014. The 2014 Non-oil GDP for the Industry grew by -0.2 percent compared with 3.6 percent in 2013.

Crops remain the largest activity in the economy with a share of 16.9 percent of nominal GDP.
