Producer Price Inflation Rate in April 2018 is 6.4%

The Producer Price Index

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers for the production of their goods and services. The PPI for Ghana reports the producer price indices with reference to September 2006, the base period. This release shows the annual (year-on-year) and monthly producer inflation rates for all industry and three major sub-sectors of industry (Mining and Quarrying, Manufacturing and Utilities) for the last twelve months. The figures for the month of April 2018 are provisional, and are subject to revision when additional data become available. All other indicators are final.

April 2018 Producer Inflation

The Producer Price Inflation rate for April 2018 was 6.4 percent. This rate indicates that, between April 2017 and April 2018 (year-on-year), the PPI increased by 6.4 percent. This rate represents a 2.7 percentage point increase in producer inflation relative to the rate recorded in March 2018 (3.7%). The month-on-month change in producer price index between March 2018 and April 2018 was 0.9 percent (Table 1).

The producer price inflation in the Mining and Quarrying sub-sector increased by 4.5 percentage points over the March 2018 rate of 5.8 percent to record 10.3 percent in April 2018. The producer inflation for Manufacturing which constitutes more than two-thirds of total industry increased by 3.0 percentage points to record 7.2 percent. The utilities sub-sector recorded inflation of -0.3 percent in April 2018 indicating an increase of 0.3 percentage point relative to the rate recorded in March 2018 (-0.6%).

Trends

In April 2017, the producer price inflation rate for all industry was 4.4 percent. The rate declined consistently to record 2.0 percent in July 2017. Subsequently, it increased consistently to record 8.3

percent in October 2017 but declined to 7.1 percent in November 2017. In December 2017, the rate increased to 8.7 percent but decreased consistently to record 5.5 percent in February 2018. In March 2018, the rate declined again to 3.7 percent but increased to 6.4 percent in April 2018.

Manufacturing Sector

During the month of April 2018, six out of the sixteen major groups in the manufacturing sub-sector recorded inflation rates higher than the sector average of 7.2 percent. Manufacture of machinery and equipment n.e.c recorded the highest inflation rate of 26.1 percent, while manufacturing of food products and beverages recorded the lowest producer price inflation rate of -0.8% (Fig. 2).

Petroleum Price Index


The producer inflation rate in the petroleum subsector was -1.2 percent in April 2017. The rate further declined to -4.5 percent in May 2017. Subsequently, it increased consistently to record 36.9 percent in October 2017 but declined to 27.7 percent in November 2017. The rate increased to 36.4 percent in December 2017 but declined consistently to record 15.9 percent in March 2018. The rate increased to 22.7 percent in April 2018. (Fig 3).


Highlights


The year-on-year producer inflation for all industry was 6.4 percent in April 2018; the monthly change rate was 0.9 percent.

The Mining and Quarrying sub-sector recorded the highest year-on-year producer price inflation rate of 10.3 percent, followed by the Manufacturing sub-sector with 7.2 percent. The Utilities sub-sector recorded the lowest year-on-year producer inflation of -0.3 percent.

With respect to the monthly changes, Manufacturing recorded the highest inflation rate of 1.2 percent, followed by the Mining and quarrying sub-sector with 0.7 percent. The utilities sub-sector recorded no change.
